What information we collect, use, and why

We collect or use the following information for student education and welfare:

- Names and contact details for students/children
- Names and contact details for carers
- Gender
- Pronoun preferences
- Payment details and financial information including transactions
- Special Educational Needs and Disabilities (SEND) or additional support information (includes reasonable adjustments and special educational needs and disabilities)
- Attendance and reason for absence data
- Exam results and qualifications
- Progress reports
- Information relating to compliments and complaints

We collect or use the following personal information for **dealing with queries**, **complaints or claims**:

- Names and contact details
- Payment details
- Attendance and reason for absence data

Lawful bases and data protection rights

Under UK data protection law, we must have a "lawful basis" for collecting and using your personal information. There is a list of possible lawful bases in the UK GDPR. You can find out more about lawful bases on the ICO's website.

Which lawful basis we rely on may affect your data protection rights which are in brief set out below. You can find out more about your data protection rights and the exemptions which may apply on the ICO's website:

- Your right of access You have the right to ask us for copies of your personal information. You can request other information such as details about where we get personal information from and who we share personal information with. There are some exemptions which means you may not receive all the information you ask for. You can read more about this right here.
- **Your right to rectification** You have the right to ask us to correct or delete personal information you think is inaccurate or incomplete. <u>You can read more about this right here</u>.
- Your right to erasure You have the right to ask us to delete your personal information. <u>You can read more about this right here</u>.
- Your right to restriction of processing You have the right to ask us to limit how we can use your personal information. <u>You can read more about this right here</u>.
- Your right to object to processing You have the right to object to the processing of your personal data. <u>You can read more about this right here</u>.
- Your right to data portability You have the right to ask that we transfer the personal information you gave us to another organisation, or to you. <u>You can read more about this right here</u>.
- Your right to withdraw consent When we use consent as our lawful basis you have the right to withdraw your consent at any time. <u>You can read</u> <u>more about this right here</u>.

If you make a request, we must respond to you without undue delay and in any event within one month.

Our lawful bases for the collection and use of your data

Our lawful bases for collecting or using personal information **for student** education and welfare are:

• Consent - we have permission from you after we gave you all the relevant information. All of your data protection rights may apply, except the right to object. To be clear, you do have the right to withdraw your consent at any time.

Our lawful bases for collecting or using personal information for **dealing with queries, complaints or claims** are:

• Consent - we have permission from you after we gave you all the relevant information. All of your data protection rights may apply, except the right to object. To be clear, you do have the right to withdraw your consent at any time.

Where we get personal information from

- Directly from you
- Parents or carers

How long we keep information

We retain personal information only for as long as necessary to fulfill the purposes for which it was collected. Specifically:

- Student Data: Retained for 1 year after the student stops using our services.
- Financial Records: Retained for 6 years to comply with UK tax requirements.

After these periods, we securely delete or anonymize the data.

How to complain

If you have any concerns about our use of your personal data, you can make a complaint to us using the contact details at the top of this privacy notice.

If you remain unhappy with how we've used your data after raising a complaint with us, you can also complain to the ICO.
